**ADVERTISEMENT**

Online applications are invited from the citizens of India for filling up of 120 posts of Sub-Inspector (Civil Police) Group-B (Non-Gazetted) and 3 posts of Sub-Inspector (IRBn) Group-B (Non-Gazetted) under the Department of Home, Govt. of Arunachal Pradesh in the Pay Matrix Level-6, Rs.35400-112400/- P.M. plus other allowances as admissible to Arunachal Pradesh Govt. from time to time. The vacancy position is subject to variation. Any vacancy/post (s) if received from Home Department will be included and notified before the written examination is held.

**1. HOW TO APPLY:**

- (a) Before applying online application for the post, candidate must mandatorily register themselves in **ONE TIME REGISTRATION (OTR)**.
- (b) Candidates are required to apply online using the website [www.appsc.gov.in](http://www.appsc.gov.in). Detail instructions for One Time Registration (OTR) and Online Application are available on the above mentioned website. The applicants are advised to submit only single application; however, if due to any unavoidable situation, if he/she submits another/multiple applications, then he/she must ensure that application with the higher Registration Ids (RID) is complete in all respect like applicants details, Photograph, signature, Photo ID, fee etc. The applicants with higher RID shall be entertained by the Commission and fee paid against one RID shall not be adjusted against any other RID.
- (c) Those candidates who have already registered in OTR need not register again and they can directly log in to fill up online form using their User ID and Password.

**2. DETAILS OF POSTS:**

The candidates who have already appeared in final examination of the qualifying Degree and awaiting for result shall also be eligible to apply. **However, such final year candidates shall have to upload Bonafide certificate to prove his/her being in a final year.** The candidates who are declares to have qualified by the Commission in Physical Standard Test and Physical Efficiency Test will have to appear in the written competitive examination, however, candidates will have to produce original certificate/marksheets of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned university will only be accepted by the Commission on or before the date of Interview/Viva-voce. Without the original certificate/marksheet they shall not be allowed to appear in the Viva-voce.

3. **AGE LIMIT:** A candidate must not be less than 21 years and above 26 years of age as on 06.11.2020. However, upper age limit is relax-able in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time in respect of Arunachal Pradesh Scheduled Tribe candidates.

4. **Candidate must possess the following minimum height and chest girth.**

(a) **HEIGHT**

Male : 165 cm (Non-APST)

Female : 157 cm (Non-APST)

: 152 cm (APST)

: 152 cm for Male and Female APST belonging from Tirap, Changlang and Longding districts of Arunachal Pradesh.

(C) **Both eye vision:** Distance vision – better eye (corrected vision) – 6/12, Near vision – J1 (corrected) J2 (corrected).

5. **Physical Efficiency Test:**

(a) 100 mtrs race - 16 seconds (Male) , 19 seconds (Female)

(b) 1500 mtrs race - 8 minutes (Male),

(c) 800 mtrs - 5 minutes (Female)

(d) High Jump - 107 cms (Male), 90 cms (Female) for 3 attempts.

(e) Long Jump - 11 feet (male), 9 feet (female) in 3 attempts.

**Note:** Physical Efficiency Test will be qualifying in nature.

6. **MEDICAL FITNESS TEST:** Those candidates who are declared to have qualified in Physical Standard Test and Physical Efficiency Test will have to appear in written examination followed by Medical Test and Viva-voce/Interview.

7. **METHOD OF SELECTION:** The eligible candidates will have to undergo Physical Standard Test and Physical Efficiency Test before appearing in written examination as given at Sl.No.4(a&b) and 5(a to e) above. And, if the no. of candidates who qualify for the written examination is huge, then the Commission will adopt Recruitment Test (Objective Type) on General Knowledge paper before the conduct of written examination.

The written examination comprised of the following subjects followed by a Medical Test at TRIHMS, Naharlagun (A.P) and Viva-voce to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which selection will be finalized.

(a) General English : 100 marks

(b) General Knowledge : 100 marks

(c) Elementary mathematics (Class-X standard) : 100 marks

(d) Viva-voce : 40 marks.

Total : 340 marks

Candidates who secure a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Viva-voce. On the other hand, it will further mean that selection for Viva-voce shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1 : 3. The candidates securing less than 33% of marks in any of written examination paper shall not be eligible for appearing in the Viva-voce.

8. Scanned copies of following documents and information are to be attached/Uploaded.

- (i) Signature of the candidate on white paper with black ink pen (20-60 kb in jpg format).
- (ii) Latest/Recent passport size photo (40-100 kb in jpg format)
- (iii) For final year student, Bonafide Certificate to be uploaded (100 kb jpg format).

Note: Candidates have to give their preference of post while filling-up the form.

**NOTE:** Candidates should not use Mobile Phone to apply online and should carefully read and understand browser information before applying online.

9. The candidates who have been declared qualified in the written examination will have to submit Xerox copies of the following documents/information to the Commission before one week from the actual date of Interview/Viva-voce.

- (i) Recent passport size photographs.
- (ii) Self-attested Xeroxed copies of Degree certificates and mark-sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- (iii) Self-attested Xeroxed copy of Matriculation certificate for proof of age issued by the Board only will be accepted.
- (iv) Self-attested Xeroxed copy of APST certificate for APST candidates and PRC/Adhaar Card/EPIC for other candidates.
- (v) All the supporting documents submitted by the candidates must be self-attested otherwise the application will be rejected.

Qualified candidates will have to produce the above mentioned certificates and mark-sheet/documents in original at the time of Interview/Viva-voce, failing which he/she will not be allowed to appear in the Interview.

10. The decision of the Commission as to the eligibility or other-wise of candidate for admission to written examination or selection will be final and no correspondence or personal enquiry will be entertained.

11. **CLOSING DATE** : 06.11.2020 till 1600 hours.

12. **EXAMINATION FEES**: Candidates are required to pay fee of Rs.100/- for APST and Rs. 150/- for others through online mode only.

13. A candidate who is or has been declared by the Commission to be guilty of:

- (a) Obtaining support for his/her candidature by any unfair means or,
- (b) Impersonation or,
- (c) Procuring impersonation by any person, or
- (d) Submitted fabricated documents or documents which have been tampered with or

- (e) Making false or incorrect statement or suppressing material fact or information or
- (f) Resorting to any other irregular or improper means in connection with his/her candidature for the examination or
- (g) Using unfair means during the examination or
- (h) Writing irrelevant matter, including obscene language or pornographic matter in the scripts or
- (i) Misbehaving in any other manner in the Examination Hall or
- (j) Harassing or doing bodily harm to the Supervisory Officers/Invigilators/Staff employed by the Commission for the conduct of examination or
- (k) Violating any of the instructions issued to the candidate along with their Admission Certificate/Call Letter permitting them to take the examination, or Commission or as the case may be attempting the Commission of all or any of the acts specified in the foregoing clauses by a candidate may, in addition to rendering him/her to criminal prosecution be liable:
  - (a) To be disqualified by the Commission from the Examination for which he/she is a candidate or
  - (b) To be debarred permanently or for specified period.
    - (i) By the Commission from any examination or selection held by them.
    - (ii) By the State Government from any employment under them and
  - (c) If he/she is already in-service under the Government, disciplinary action under the relevant rules shall be instituted.
  - (d) Provided that no penalty under these rules shall be imposed except after:
    - (i) Giving the candidate an opportunity of making such representation in writing as he/she wishes to make in that behalf and
    - (ii) Taking the representation if any, submitted by the candidate within the period allowed to him into consideration.
    - (iii) Provided further that if any candidate found to have been debarred by any other Commission the candidate shall stand so debarred for the purpose of this Commission.
