**Recruitment of contractual post of Community Health Officer (CHO) Contractual Positions under National Health Mission (NHM)**

The National Health Mission (NHM), Rajasthan (Rajasthan State Health Society) invites applications from eligible candidates for the contractual post of Community Health Officer (CHO) on purely contractual basis at Health & Wellness Centers (SHC-H&WCs) as per operational guidelines of Ayushman Bharat Comprehensive Primary Health Care through Health and Wellness Centres.

1. Candidates are required to deposit requisite application fee for the applied position through E-Mitra. E Mitra charges Rs 50 will be extra from the above application fees, which is payable to E mitra.
2. Candidates who have earlier applied for the position of the CHO in reference with advt. No: F.20(504)/HR/CHO recruitment/2019/ 898 dated 16-05-2019 and deposited application fees. Their application fees will be adjusted subject to submission of receipt number/ transaction ID at the time of filling application form. However the E Mitra charges Rs 50 will be borne by the candidate.

## Other terms & conditions :-

1. Candidate must have registration certificate from concerned Rajasthan Nursing Council / Board of Indian Medicine Rajasthan at the time of online submission of the application or must have applied for registration in concerned Rajasthan Nursing Council / Board of Indian Medicine Rajasthan before submission of online application. Candidate must submit a valid registration certificate issued by concerned concerned Rajasthan Nursing Council / Board of Indian Medicine Rajasthan at the time of document verification otherwise his/her selection will be cancelled for the contractual post of CHO.
2. Candidates having more than 2 live children born on or after 01.06.2002 are not eligible for contractual post of CHO as per Department of Personnel (A group-II), Government of Rajasthan's Notification No. F.7(1)DOP/A-II/95 dated 20-06-2001.
3. All Candidates have to appear for a screening exam and short listed candidates
  - a. having Certificate in Community Health (CCH) / B.Sc in Community Health will be posted on contractual post of CHO in SHC-H&WCs.
  - b. Who do not have Certificate in Community Health (CCH) have to pass the 6 months bridge course successfully.
    - i. If Candidate is not successful in the Bridge Course in first attempt, he/she shall be given one more opportunity(at the willingness of candidate) and for this second opportunity the fees and other expenditure of Bridge Course shall be borne by candidate himself/herself.
    - ii. If any candidate is not qualified even after availing second opportunity, such candidates shall not be considered for the contractual post of CHO.
4. Short listed candidate, if employed, shall have to submit NOC from the employer before joining the 6 months Bridge Course and must resign from the post held before joining the contractual post of CHO.
5. No document is to be attached/ uploaded with online application except Passport Size recent Photograph and scanned Signature.
6. Only online Application shall be accepted. Applications sent by post/by hand shall not be entertained in any case.
7. Candidates are solely responsible for the correctness/ sanctity of all the information regarding educational qualification and other eligibility criteria in Online Application Form.
8. Short listing for the contractual post of CHO shall be done on the basis of merit of screening exam. Screening examination will be conducted through Multiple Choice Questions (MCQ) based written exam and other eligibility criteria mentioned above.
9. The written examination information details (Date, time, venue and guidelines etc.) for the contractual post of CHO shall be made available separately on website.
10. The provision of reservation shall be applicable as per rules/guidelines issued by the Government of Rajasthan.
11. Short listing for the contractual post of CHO shall depend on production of original documents by the candidate during documents verification process.
12. Any pre selection queries shall not be entertained.
13. Candidates shall receive communication via departmental website / News papers.
14. Department can verify the educational certificates and other documents related to eligibility from the issuing authority at any point of time and take action accordingly.
15. Appointment to posts based on a system of "counselling" (Merit Cum Preference) where those higher on the final merit list get to choose first from the posts that are vacant. The State Health Society, Rajasthan will however retain the right to transfer them, usually within the district or state, if a need to do so arises.

16. Request for the place of posting after selection at particular place shall not be entertained at all.
17. Short listed candidate shall have to submit a Bond of Rs. Five lacs on Rs 500 Non Judicial Stamp paper duly notarized to serve at SHC-HWC for a period of 5 years before joining the Bridge Course.
18. The honorarium shall commence only after joining on the position of the contractual post of CHO at allocated SHC-HWC. No honorarium shall be given before or during Bridge Course.
19. The cost of six months Bridge course in Community Health shall be borne by NHM Rajasthan as per Record of Proceedings (approved PIP) of the respective year and operational guidelines by Government of India.
20. These contractual post of CHO are purely on contractual basis and terms of service are governed as per Finance (Rules/Circular) Department Circular F.1(4)/Rules/2011/part II dated 27.06.2014 .
